Note to Entrants: This Competition is conducted under the conditions of FAMB Limited By-Law 2.

1. Each entry must be a non-professional production and not made for profit.
2. The entrant shall be responsible for copyright.
3. Each movie maker must read and understand the rules and sign the Entry Form.
4. Maximum length of movies shall be fifteen minutes.
5. No movie shall carry a title showing success in another competition.
6. Entries are to be made in digital format either on tape or optical disc.
7. Sound tracks must not be made in professional studios by professionals.
8. The decision of the Executive of the Federation shall be final in regards to appeals, disputes and the interpretation of these rules and conditions.
9. The Competition entries close on the nominated date. Entry Forms are to be sent to The Competition Secretary, Movies to be sent to the Convention Committee as stated.
10. The entrant grants the right to the Federation to duplicate the entry as per By-Law 2.
11. Movies made by a Group or as a Club Production must be named accordingly.
12. The Club may enter five movies and must preferentially rate each (refer to By-Law 2 Clauses 48 and 49).
13.
